

## **Correction regarding bulletin from the Annual General Meeting of Betsson AB (publ)**

In the previously published bulletin from the Annual General Meeting of Betsson AB (publ) on 11 June 2020, it was announced that the Annual General Meeting had decided on, among other things, the share split and an automatic redemption procedure. The bulletin stated that the decision on the redemption procedure for class B shares amounted to 122,155,730, the correct number of shares should be 122,504,730.

This does not affect the previously decided redemption proceeds of SEK 393.6 million, corresponding to SEK 2.88 per share to be distributed to the Company's shareholders. The amount was calculated on the total number of shares, amounting to 144,493,238 million shares, with any withdrawn shares held by the Company not eligible for repayment.
